The Town Board will bill Day Springs Homeowners Association for plowing 5 times.

Sue will check on billing the bank for plowing the road to the one house of Development Finance Corp property.

Treasurer's report was read, checks were prepared for the bills and signed. Claim numbers 10202-10220...totaling \$34,623.74

John Frederickson and Garris Anderson maintenance employees qualify for PERA. David has submitted the paperwork and an invoice will follow. New Business:

- -Stan was summoned by the local authorities to sand and salt Olympic Trail following the Nelson house fire
- -the old truck is at Shafer Auto for repair...needs a new belt
- -New township truck...AP will give prices on a $\frac{1}{2}$ or $\frac{3}{4}$ ton 4 wheel drive. Verner will price both.
- -Sue contacted Chisago and will contact Osceola students about election

judge trainee for our election... Nation Honors Society was another suggestion.

- -Sue will pursue getting flyers for the Atlas program at the Chisago Library.
- -Sue sent email to Tara...Rush City is the next location for cell tower. Tara seems miss-informed about our request for free space for the 800mg addition to the new mono-pole on Jerry Vitalis' property. Jan 6th is the Planning Commission meeting on this issue.
- -Warren White issue...he wants \$12,782.81 to satisfy the 260th and Th 95 Street project.....Verner asked for suggestions, discussion followed, Verner moved to pay Warren \$10,000 per the proposal at the Oct board meeting, Sue seconded, motion carried.
- -followed up with Daryl Moller, County Assessor regarding the easement on Oldfield. He doesn't care if the road gets vacated or not as a better description has been researched and the parcel now appears on the County Plat
- -Park Commission...they are updating park plan...will report in January.
- -Suzi called the MN Township paper and corrected the filing dates for election.
- -Sue wants to start working on budgets.
- -Dave reported that there is no insurance compensation for wind damage for the shingles on the town hall roof.
- -Ryan affirmed Stan should go to a road blacktop maintenance and repair class but should be required to take notes and explain to the supervisors best practices learned....Verner suggested the board look into it
- -Info from Jim Birkholz.... Soil and Water State-wide Conservation project gets money (\$380,000) for working with the county...possibility for work in Franconia Township. If the town board knows of projects, contact Jim Birkholz.
