The meeting was called to order by Verner Greene Jr. at 7:31 p.m. The pledge of allegiance was waived.

- Claims submitted \$7,422.74

Jim Birkholz motioned to approve the Treasurer's Report and Sue Thompson seconded; motion carried 3-0.

#### **Clerk's Report:**

Jim Birkholz and Stan Anderson will be here to unlock the door and greet Chip Cravaack's office representatives. They will be setting up a temporary office in our town hall December 2, 2011, to answer citizens questions from 10:30 a.m. to 12:00 p.m.

Missy Glenna will be attending the MAT Annual Conference in Alexandria, Minnesota, on November 17-19, 2011.

### **Old Business:**

- Jim Birkholz stated that the roads that gravel was recently added to, Panola (west of Olinda), 280<sup>th</sup>, and N. Quinlan, all look good. Stan did a nice job. RE Peterson hauled the gravel. This was all done for around \$35,000.
- Regarding plowing for Day Spring, they are waiting for our response. Verner Greene Jr. motioned to charge \$105 per hour + \$5 invoicing fee with a 1 hour minimum. Sue Thompson seconded the motion; motion carried 3-0.
- Regarding the township lot for sale, discussion was had about how much to charge. Sue Thompson will let Neil know we are searching the value of the lot and that we are trying

to come up with a good price. Jim will contact Kelly Strobel in zoning about septic system rules.

- Regarding the summons, thank you to Sue Thompson for contacting attorney Kevin Hofstad. We may need to use him in the future.
- Center City Fire wants to increase our contract with them from \$3,600 to \$5,000.

### **New Business:**

- Jim Birkholz stated that there is a County Park Advisory Board vacancy. The deadline to apply is November 30, 2011. Sue Thompson will put this on the website.
- Sue Thompson brought an Inventory Report. Reassessment will be the first meeting after the annual meeting.
- MN DOT 2012 project on Highway 8 wants to know Franconia businesses. Sue Thompson will put this request on the website to inform Franconia businesses.
