## Set 2022 Budget/Levy

Proposed 2022 budget/levy - General Fund - \$70,000.00; Equipment Fund -\$30,000.00; Fire Fund - \$50,000.00; Road & Bridge Fund - \$470,000.00; Road Maintenance Fund - \$20,000.00; Blacktopping Fund - \$150,000.00; Shafer Franconia Fire Truck & Building Fund - \$30,000.00; Township Hall Building & Maintenance Levy - \$50,000.00 for a total 2022 levy of \$870,000.00. This is a 0% increase from the 2021 levy. A motion to present the citizens at the annual meeting the proposed 2022 levy was made by Dennis Gustafson and seconded by Owen Kuhnly. Motion carried.

A motion was made by Dennis Gustafson, seconded by Owen Kuhnly, to correct funds withdrawn from the Road Maintenance Fund to be withdrawn from the Road & Bridge fund for the repair of 260<sup>th</sup>. Motion carried.
