Call to Order

Approve Agenda

Approval of Previous Minutes

Dayspring Development – Doug Wallis reported that the developers have been calling him asking when the township was going to do something with the roads so they could start selling their lots. Resolutions – Doug Wallis made a motion to approve Resolution No. 2023-11-14-01 designating the Franconia Town Hall as the polling place for Franconia Township residents for the 2024 elections, seconded by Sonny Sparby. Motion carried.

Sonny Sparby made a motion to approve the Voter Fund Allocation Agreement, which allocates state election funds of \$130.02 originally allocated to Franconia Township for 2024 elections back to Chisago County to help cover 2024 election expenses, seconded by Doug Wallis. Motion carried.

Earned Sick and Safe Leave – Owen Kuhnly asked the board members to read through the information on the three options for employees that work more than 30 hours a year and put a discussion about which of the three options to implement on the December 2023 town board meeting agenda.

Engineering Report

Culvert Letters – Chuck Fitzer will send letters, by certified mail, to two township residents requiring that they have their culverts repaired by June 15, 2024. If the residents do not have their culverts repaired by June 15, 2024, the township will have the culverts repaired and add the costs to the affected residents' property taxes.
